Invitation for Tender

TENDER FOR HARBOUR HEAD BRIDGE CONSTRUCTION, PORT MORANT ST. THOMAS

The National Works Agency invites eligible contractors to submit tenders for the reconstruction of the Harbour Head Bridge, Port Morant St. Thomas. The works include but is not limited to excavation, demolition of existing bridge, piling works, construction of bridge abutments, assembling and launching of compact 200 bridge, scour protection works, limited base construction and Asphaltic Concrete pavement.

Eligibility: It is mandatory that contractors be on the National Contracts Commission (NCC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grades 1 or 2 in the Bridge Construction or Civil Engineering category.

Availability: Tender Documents will be made available as of Tuesday April 7, 2015, at the National Works Agency's, Corporate Office, 140 Maxfield Avenue, Kingston 10, in the Directorate of Major Projects.

Fee: A non-refundable payment of J\$5,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Tender Security: A Tender Bond issued by a registered bank or insurance company in the amount of \$1,600,000 or a Manager's Cheque in the sum of \$800,000, made payable to the "Chief Executive Officer - National Works Agency" will be required as part of the bid.

Return of Tenders: Completed tenders along with the required documents [National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), etc.] are to be placed in an envelope labelled "BRIDGE CONSTRUCTION WORKS: HARBOUR HEAD BRIDGE, ST. THOMAS." The envelope should then be placed in the Tender Box similarly labelled and located in the Lobby of the National Works Agency's Corporate Office, 140 Maxfield Avenue, Kingston 10, no later than 10:00 a.m. on Tuesday, April 28, 2015.

Tender Opening: The Tenders will be opened at **10:15 a.m. on April 28, 2015** in the Main Conference Room, at the National Works Agency, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

All queries concerning the Tender Document shall be made in writing and addressed to The Directorate, Major Projects, National Works Agency, 140 Maxfield Avenue, Kingston 10, by **Tuesday, April 21, 2015.**

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and NCC Certificate of Registration will be rejected
