The National Works Agency, an Executive Agency of the Ministry of Transport, Works and Housing, with funding from the Government of Jamaica, invites eligible contractors to submit tender for the Installation of New Traffic Signals at Munroe Road - Wellington Avenue and Old Hope Road - Retreat Avenue

**Eligibility:** It is mandatory that contractors be on the National Contracts Commission (NCC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grades 1, 2 or 3 of the Civil Engineering Category and have a valid Tax Compliance Certificate (TCC).

**Availability:** Tender documents will be available as of **Monday, July 27, 2015** at the National Works Agency's Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Planning & Research Directorate.

**Fee:** A non-refundable fee of Two Thousand Dollars (\$2,000.00) cash or Manager's Cheque payable to the Chief Executive Officer, National Works Agency will be required for each set of Tender documents.

**Return of Tenders:** Completed tender documents, along with the required copies of a valid Tax Compliance Certificate (TCC) and a current National Contracts Commission Certificate of Registration in the appropriate category and grade are to be placed in an envelope marked "**Installation of New Traffic Signals - Package B.**" The envelope is to be placed in the Tender Box similarly labelled and located in the Lobby of the National Works Agency, 140 Maxfield Avenue, Kingston 10, no later than **10:00 a.m. on Monday, August 10, 2015.**

**Tender Opening:** Tenders will be publicly opened on **Monday, August 10, 2015 at 10:15 a.m.** in the Planning & Research Conference Room at the National Works Agency, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.
