TENDER FOR ROAD REHABILITATION: ENSOM ACRES and NEWTON CLOSE, ST. CATHERINE

The National Works Agency invites eligible contractors to submit tenders for Road Rehabilitation Works: Ensom Acres and Newton Close, St. Catherine. The works include but is not limited to earth works, and pavement application, as specified.

Eligibility: It is mandatory that contractors be on the National Contracts Commission (NCC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grades 1, 2 or 3 in the Civil Engineering or General Roadworks or Asphaltic Concrete Work category.

Availability: Tender Documents will be made available from **Monday, June 19, 2017, until Monday, July 03, 2017** from the National Works Agency's, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

Fee: A non-refundable payment of J\$3,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each Tender Document.

Return of Tenders: Completed tenders along with the required documents: National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), etc. are to be placed in an envelope labelled "**ROAD REHABILITATION WORKS, ENSOM ACRES and NEWTON CLOSE, ST. CATHERINE**". The envelope should then be placed in the Tender Box similarly labelled and located in the Lobby of the National Works Agency, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **10:00 a.m. on Tuesday, July 4, 2017.**

Tender Opening: The Tenders will be opened at **10:15 a.m. on July 4, 2017** in the Main Conference Room, at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.
