The works comprise of but is not limited to site clearance, earth works including excavation, engineering fill. Drainage construction such as HPDE pipe installation and construction of U drain. Pavement works to include preparation of formation, base course, asphaltic overlay (38 mm thick), walling and masonry, rubble and reinforced concrete walls, and kerb and channel.

Eligibility: It is mandatory that contractors be on the Public Procurement Commission (PPC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grade 1 -2 in the Civil Engineering Works or General Road Works Categories. Tenderers must have a valid Tax Compliance Certificate (TCC).
