## TENDER FOR RETAINING WALL CONSTRUCTION & DRAINAGE IMPROVEMENT WORKS: Nolan Hill Breakaway (No. 2), St. Andrew

The National Works Agency invites eligible contractors to submit **TENDERS FOR NOLAN HILL BREAKAWAY (No. 2), LOCATED IN THE PARISH OF ST.ANDREW**. The works comprise of but is not limited to site clearance, earth works including excavation and engineering fill; drainage construction such as HPDE pipe installation and construction of U drain; pavement works to include preparation of formation, base course, asphaltic overlay (38 mm Thick), walling and masonry, rubble and reinforced of concrete walls as well as kerb and channel.

**Eligibility:** It is mandatory that contractors be on the Public Procurement Commission (PPC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grade 1 -2 in the Civil Engineering Works Category. Tenderers must have a valid Tax Compliance Certificate (TCC).

**Availability:** Tender Documents will be made available as of **Tuesday, May 12, 2020**, at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

Fee: A non-refundable payment of J\$5,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Return of Tenders: PPC Certificate of Registration and a valid Tax Compliance Certificate (TCC), are to be placed in an envelope labelled "RETAINING WALL CONSTRUCTION & DRAINAGE IMPROVEMENT WORKS: NOLAN HILL BREAKAWAY (NO. 2) LOCATED IN THE PARISH OF ST.
