TENDER FOR RETAINING WALL CONSTRUCTION & DRAINAGE IMPROVEMENT WORKS: Nolan Hill Breakaway (No. 2), St. Andrew

The National Works Agency invites eligible contractors to submit **TENDERS FOR NOLAN HILL BREAKAWAY (No. 2), LOCATED IN THE PARISH OF ST. ANDREW**. The works comprise of but is not limited to site clearance, earth works including excavation and engineering fill; drainage construction such as HPDE pipe installation and construction of U drain; pavement works to include preparation of formation, base course, asphaltic overlay (38 mm Thick), walling and masonry, rubble and reinforced of concrete walls as well as kerb and channel.

Eligibility: It is mandatory that contractors be on the Public Procurement Commission (PPC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grade 1 -2 in the Civil Engineering Works Category. Tenderers must have a valid Tax Compliance Certificate (TCC).

Availability: Tender Documents will be made available as of **Tuesday, May 12, 2020**, at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

Fee: A non-refundable payment of J\$5,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Return of Tenders: PPC Certificate of Registration and a valid Tax Compliance Certificate (TCC), are to be placed in an envelope labelled **"RETAINING WALL CONSTRUCTION & DRAINAGE IMPROVEMENT WORKS: NOLAN HILL BREAKAWAY (NO. 2) LOCATED IN THE PARISH OF ST. ANDREW"**. The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **10:00 a.m. on Monday, June 8, 2020**.

Tender Opening: The Tenders will be opened at **10:15 a.m. on Monday, June 8, 2020** in the Conference area of the Regional and Special Projects Department, National Works Agency, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.
