Invitation To Tender

RIVER TRAINING: CHATSWORTH BREAKAWAY, PORTLAND

The National Works Agency invites eligible contractors to submit tenders for **RIVER TRAINING, CHATSWORTH LOCATED IN THE PARISH OF PORTLAND**. The works consist of but not limited to: Earthworks (granular fill), Construction of rubble masonry retaining wall. Road Works include: scarifying, preparation of formation, base course and asphaltic concrete (38mm thick); Ancillary works require kerb and concrete channel construction. River Training Works include the construction of concrete channels and gabion walls.

Eligibility: It is mandatory that contractors be on the National Contracts Commission (NCC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grades 1 or 2 in the Civil Engineering Works or General Road Works Categories. Tenderers must have a valid Tax Compliance Certificate (TCC).

Availability: Tender Documents will be made available as of **Tuesday, February 5, 2019**, at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

Fee: A non-refundable payment of J\$3,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Return of Tenders: Completed tenders along with a Bid Security (\$200,000.00) in the form of a manager's cheque from a local bank or tender bond from an insurance company, National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), are to be placed in an envelope labelled "**RIVER TRAINING: CHATSWORTH BREAKAWAY LOCATED IN THE PARISH OF PORTLAND**". The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **11:00 a.m. on Monday, February 18, 2019**.

Tender Opening: The Tenders will be opened at **11:15 a.m. on Monday February 18, 2019**, in the Main Conference Room, National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and NCC Certificate of Registration will be rejected.
