## TENDER FOR ROAD REHABILITATIVE WORKS: FAIRFIELD – RETIREMENT (TUCKER MAIN ROAD), ST. JAMES

The National Works Agency invites eligible contractors to submit tenders for Road Rehabilitative Works for Fairfield to Retirement (Tucker Main Road) located in the parish of St. James. The works consist of demolition and site clearance, kerb & channel construction, walling and masonry, drainage and pavement works.

**Eligibility:** It is mandatory that contractors be on the National Contracts Commission (NCC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grades 1 or 2 in the Civil Engineering Works or General Road Works Categories.

**Availability:** Tender Documents will be made available as of **Tuesday September 4, 2018** at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10 from the Directorate of Regional Implementation & Special Projects.

**Fee:** A non-refundable payment of J\$3,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Return of Tenders: Completed tenders along with the Bid Security of \$300,000.00 in the form of a manager's cheque from a local bank or insurance company, National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), are to be placed in an envelope labelled "Road Rehabilitative Works for Fairfield – Retirement (Tucker Main Road), St. James" The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than 11:00 a.m. on Wednesday, September 25, 2018.

**Tender Opening:** The Tenders will be opened at **11:15 a.m., Wednesday, September 25, 2018**, in the Regional Implementation & Special Projects Conference Area, National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.
