TENDER FOR ROAD REHABILITATION WORKS: GREENVALE BOULEVARD (FERDIE NEITA BOULEVARD), ST. CATHERINE

The National Works Agency invites eligible contractors to submit **TENDERS FOR ROAD REHABILITATION WORKS: GREENVALE BOULEVARD (FERDIE NEITA BOULEVARD) LOCATED IN THE PARISH OF ST. CATHERINE**. The works consist of demolition & site clearance, earthworks – excavation, drain cleaning and pavement works such as scarifying, preparation of formation, base course, application of asphaltic concrete overlay, concrete works and ancillary works (sidewalk construction, road signage, kerb & channel).

Eligibility: It is mandatory that contractors be on the National Contracts Commission (NCC)/Public Procurement Commission (PPC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grade 1 or 2 in the Civil Engineering Works or General Road Works Categories. Tenderers must have a valid Tax Compliance Certificate (TCC).

Availability: Tender Documents will be made available as of **Monday, November 18, 2019**, at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

Fee: A non-refundable payment of J\$5,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Return of Tenders: Completed tenders along with a Public Procurement Commission (PPC) /National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), are to be placed in an envelope labelled **"ROAD REHABILITATION WORKS: GREENVALE BOULEVARD (FERDIE NEITA BOULEVARD) LOCATED IN THE PARISH OF ST. CATHERINE"**. The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **10:00 a.m. on Wednesday, December 4, 2019**.

Tender Opening: The Tenders will be opened at **10:30 am on Wednesday, December 4, 2019**, in the Regional and Special Projects Conference table, National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and NCC Certificate of Registration will be rejected.
