### Invitation To Tender

#### ROAD REHABILITATION WORKS: PORTO BELLO ROAD, ST. JAMES

The National Works Agency invites eligible contractors to submit tenders for **ROAD REHABILITATION WORKS: PORTO BELLO ROAD, ST. JAMES**. The works include but is not limited to earth works, drainage construction, preparation of formation and application of 38mm thick asphaltic concrete overlay along the road section as specified.

**Eligibility:** It is mandatory that contractors be on the National Contracts Commission (NCC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grades 1 or 2 in the Civil Engineering or General Road works category.

**Availability:** Tender Documents will be made available from **Tuesday January 29, 2019 until Tuesday, February 12, 2019** from the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

**Fee:** No applicable fees.

**Tender Security:** Bid Security shall be \$300,000.00 from a local banking institution in the form of a manager's cheque or tender bond from an insurance company made payable to the "Chief Executive Officer - National Works Agency".

**Return of Tenders:** Completed tenders along with the required documents: National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC) are to be placed in an envelope labelled "**ROAD REHABILITATION WORKS: PORTO BELLO ROAD, ST. JAMES**". The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **10:00 a.m. on Tuesday, February 12, 2019**.

**Tender Opening:** The Tenders will be opened at **10:15 a.m. Tuesday, February 12, 2019** in the Main Conference Room, at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.
