Invitation To Tender

TENDER FOR ROAD REHABILITATION: SAVANNAH CROSS, CLARENDON

The National Works Agency invites eligible contractors to submit tenders for **ROAD REHABILITATION: SAVANNAH CROSS, LOCATED IN THE PARISH OF CLARENDON**. The works consist of site clearance, earthworks, excavate to reduce levels. Pavement works such as sub base and, base course, prime coat and asphaltic concrete overlay 50mm thick. Walling, masonry and fencing. Drainage construction of kerb and channel. Install traffic signal and signs.

Eligibility: It is mandatory that contractors be on the National Contracts Commission (NCC)/ Public Procurement Commission (PPC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grade 1 or 2 in the Civil Engineering Works or General Road Works Categories. Tenders must have a valid Tax Compliance Certificate (TCC).

Availability: Tender Documents will be made available as of **Monday, December 16, 2019**, at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10, in the Directorate of Regional Implementation & Special Projects.

Fee: A non-refundable payment of \$5,000.00 in cash or Manager's Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Return of Tenders: Completed tenders along with Bid Security (300,000.00) in the form of a manager's Cheque from a local bank or tender bond from an insurance company, Public Procurement Commission (PCC)/ National Contracts Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), are to be placed in an envelope labelled **"ROAD REHABILITATION WORKS SAVANNAH CROSS, LOCATED IN THE PARISH OF CLARENDON"**. The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **10:00 a.m. on Tuesday January 14, 2020**.

Tender Opening: The Tenders will be opened at **10:15 a.m. on Tuesday, January 14, 2020**, in the Conference area of the Regional and Special Projects Department, National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and PPC Certificate of Registration will be rejected.
