## **Invitation for Tender**

## PROCUREMENT OF WORKS FOR THE INSTALLATION OF ROAD MARKINGS ALONG THE NORTH COAST HIGHWAY FROM ISLAND VILLAGE (OCHO RIOS) TO RUNAWAY BAY

The National Works Agency, an Executive Agency of the Ministry of Economic Growth and Job Creation, through funding from the Tourism Enhancement Fund, invites eligible contractors to submit tenders for the installation of road markings along the Northern Coastal Highway from Island Village (Ocho Rios) to Runaway Bay.

**Eligibility:** Tenderers shall be registered with the National Contracts Commission (NCC) at the specified level in any of the following categories for their tenders to be eligible: General Road Works-Grades 1-2; Civil Engineering -Grades 1-2 Tenderers must also possess a valid Tax Compliance Certificate (TCC).

**Availability:** Tender Documents will be available as of **Tuesday, July 11, 2017**, from the Office of the Directorate of Planning & Research, National Works Agency, 140 Maxfield Avenue, Kingston 10.

**Fee:** A non-refundable fee of Two Thousand Dollars (\$2,000.00) cash or Manager's Cheque payable to the Chief Executive Officer, National Works Agency, will be required for Tender Documents.

Return of Tenders: The complete set of Tender Documents along with the other required documents: [National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), etc.] should be completed for the procurement and placed in an envelope labelled "INSTALLATION OF ROAD MARKINGS ALONG THE NORTH COAST HIGHWAY FROM ISLAND VILLAGE (OCHO RIOS) TO RUNAWAY BAY". The envelope is to be placed in the Tender Box similarly labelled and located in the Lobby of the National Works Agency, 140 Maxfield Avenue, Kingston 10, no later than 10:00 a.m. on Monday, July 31, 2017.

**Opening of Tenders:** Bids will be publicly opened on **Monday, July 31, 2017 at 10:45 a.m.** in the Planning & Research Conference Room, National Works Agency, 140 Maxfield Avenue, Kingston 10.

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and National Contract Commission (NCC) Certificate of Registration will be rejected.

THE NATIONAL WORKS AGENCY reserves the right not to accept the lowest or any other tender, or to annul the tender process and reject all tenders at any time prior to the award without incurring any liability.
