### Invitation for Tender

#### CONSTRUCTION OF BOX CULVERT: WOOD HALL, ST. CATHERINE

The National Works Agency invites eligible contractors to submit tenders for Construction of Box Culvert: Wood Hall, St. Catherine. The proposed works to be implemented comprises, but not limited to, demolition of existing structure, earth works, construction of box culvert, gabion basket works for river training and scour protection, limited base construction and Asphaltic Concrete pavement.

**Eligibility:** It is mandatory that contractors be on the National Contracts Commission (NCC) List of Registered Contractors at the specified level in the following category for their tenders to be eligible: Grades 2 or 3 in the Civil Engineering Works category.

**Availability:** Tender Documents will be made available as of **Wednesday, April 22, 2015**, at the National Works Agency's, Corporate Office, 140 Maxfield Avenue, Kingston 10, in the Directorate of Major Projects.

**Fee:** A non-refundable payment of J\$5,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

**Tender Security:** A Tender Bond issued by a registered bank or insurance company in the amount of \$400,000 or a Manager's Cheque in the sum of \$200,000 made payable to the "Chief Executive Officer - National Works Agency".

**Return of Tenders:** Completed tenders along with the required documents [National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), etc.] are to be placed in an envelope labelled "**CONSTRUCTION OF BOX CULVERT: WOOD HALL, ST. CATHERINE.**" The envelope should then be placed in the Tender Box similarly labelled and located in the Lobby of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10 no later than **10:00 a.m. on Wednesday, May 20, 2015.**

**Tender Opening:** The Tenders will be opened at **10:15 a.m. on May 20, 2015** in the Main Conference Room, at the National Works Agency, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

***Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and NCC Certificate of Registration will be rejected.***
