TENDER FOR BRIDGE REHABILITATION WORKS: FORUM BRIDGE, ST. CATHERINE

The National Works Agency invites eligible contractors to submit tenders for Bridge Rehabilitation Works: Forum Bridge, St. Catherine. The works include but is not limited to excavation, demolition and replacement of bridge abutment back walls, replacement of bearing pads, sand blasting of bridge steel structure, spalling concrete repairs, limited base and Asphaltic Concrete replacement.

Eligibility: It is mandatory that contractors be on the National Contracts Commission (NCC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grades 1, 2 or 3 in the Bridge Construction or Civil Engineering Works categories

Availability: Tender Documents will be made available as of Tuesday March 24, 2015, at the National Works Agency's, Corporate Office, 140 Maxfield Avenue, Kingston 10, in the Directorate of Major Projects.

Fee: A non-refundable payment of J\$5,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Tender Security: A Tender Bond issued by a registered bank or insurance company in the amount of \$1,500,000 or a Manager's Cheque in the sum of \$750,000 made payable to the "Chief Executive Officer - National Works Agency" must also accompany the Bid.

Return of Tenders: Completed tenders along with the required documents National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), etc. are to be placed in an envelope labelled **"BRIDGE REHABILITATION WORKS: FORUM BRIDGE, ST. CATHERINE."** The envelope should then be placed in the Tender Box similarly labelled and located in the Lobby of the National Works Agency's, Corporate Office, 140 Maxfield Avenue, Kingston 10, no later than **10:00 a.m. on Tuesday, April 21, 2015.**

Tender Opening: The Tenders will be opened at **10:15 a.m. on April 21, 2015** in the Main Conference Room, at the National Works Agency, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

A site meeting with the prospective tenders is schedule for **Friday, April 10, 2015 at 10:00 a.m.** at the bridge site.

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and NCC Certificate of Registration will be rejected
