## TENDER FOR DRAINAGE IMPROVEMENT WORKS: BUFF BAY, PORTLAND.

The National Works Agency invites eligible contractors to submit **TENDERS FOR DRAINAGE IMPROVEMENT WORKS, BUFF BAY LOCATED IN THE PARISH OF PORTLAND**. The works comprise of but is not limited to soak away construction, stone packing, steel reinforcements, manholes, disposal of excavated materials; U drain construction to include excavation, manholes, blinding, steel reinforcements to concrete beams and base. Installation of 600 mm diameter HDPE pipe culvert. Pavement works such as scarifying, preparation of formation, base course and asphaltic concrete overlay (38mm thick).

**Eligibility:** It is mandatory that contractors be on the Public Procurement Commission (PPC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grade 1 - 2 in the Civil Engineering or General Road Works Category. Tenderers must have a valid Tax Compliance Certificate (TCC).

**Availability:** Tender Documents will be made available as of **Thursday, May 14, 2020**, at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

**Fee:** A non-refundable payment of J\$5,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Return of Tenders: Completed tenders along with a Bid Security (\$300,000.00) in the form of a Manager's Cheque, bank guarantee from a local bank or Tender Bond from an insurance company PPC Certificate of Registration and a valid Tax Compliance Certificate (TCC), are to be placed in an envelope labelled "DRAINAGE IMPROVEMENT WORKS: BUFF BAY LOCATED IN THE PARISH OF PORTLAND". The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than 10:00 a.m. on Friday, June 19, 2020.

**Tender Opening:** The Tenders will be opened at **10:15 a.m. on Friday, June 19, 2020**, in the Conference area of the Regional and Special Projects Department, National Works Agency, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.
