Invitation To Tender

TENDER FOR ROAD REHABILITATION:

Hermitage Dam Road (Stony Hill - Gibson Road), St. Andrew

The National Works Agency invites eligible contractors to submit tenders for Road Rehabilitative Works for Hermitage Dam Road (Stony Hill - Gibson Road) located in the parish of St. Andrew. The works consist of Pavement works, Base Course, Prime Coat, Asphaltic Concrete 38mm Thick overlay.

Eligibility: It is mandatory that contractors be registered with the Public Procurement Commission (PPC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grades 1 or 2 in the Civil Engineering Works or General Road Works Categories.

Availability: Tender Documents will be made available as of **Wednesday, August 28, 2019,** at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

Fee: A non-refundable payment of J\$5,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Return of Tenders: Completed tenders along with the Bid Security (\$400,000.00) in the form of a manager's cheque from a local bank or tender bond from an insurance company. Public Procurement Commission (PPC) Certificate of Registration and a valid Tax Compliance Letter (TCL), are to be placed in an envelope labelled "**ROAD REHABILITATIVE WORKS FOR HERMITAGE DAM ROAD** (STONY HILL - GIBSON **ROAD**), LOCATED IN THE PARISH OF ST. ANDREW". The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **10:00 a.m. on Wednesday, September 18, 2019.**

Tender Opening: The Tenders will be opened at **10:45 a.m. on Wednesday**, **September 18, 2019**, in the Regional Implementation & Special Projects Conference Area, National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

All queries concerning the Tender Document shall be made in writing and addressed to: **Moira Williamson, Major Projects Manager (Acting),** National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10; by September 9th, 2019.

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and (PPC) Certificate of Registration will be rejected.
