Invitation for Tender

RECONSTRUCTION OF PASSAGEFORT DRIVE/DYKE ROAD MULTI BOX CULVERTS, ST. CATHERINE

The Government of Jamaica, through the Ministry of Economic Growth and Job Creation/ National Works Agency invites eligible contractors to submit tenders for the captioned works.

The Scope of Works: Demolition of existing partially collapsed four (4) cell metal pipe culverts, propping of National Water Commission sewer pipelines, sub excavation of soft soils to firm strata, placement of engineering fill to form bearing strata, construction of 4 Nos. 2.5 meters wide by 3.5 meters high reinforced concrete box culverts, placement of engineering fill to abuttment and asphalting of approach road.

Eligibility: Tenderers must be registered with the National Contracts Commission in the Civil Engineering Works Category Grade 1 and shall be in possession of valid Tax Compliance Certificates (TCC) in order to have their tenders considered.

Availability: Tender Documents will be available as of Monday, February 26, 2018 from the Directorate of Technical Services, National Works Agency, 140 Maxfield Avenue, Kingston 10.

Fee: A non-refundable payment of Three Thousand Dollars (\$3,000.00) in cash or manager's cheque, payable to the Chief Executive Officer, National Works Agency is required for each set of Tender Documents.

Return of Tenders: Completed Tender Documents together with all required enclosures (NCC registration and TCC) should be placed in an envelope marked "RECONSTRUCTION OF PASSAGEFORT DRIVE/DYKE ROAD MULTI BOX CULVERTS, ST. CATHERINE." The envelope is to be placed in the Tender Box similarly labelled and located in the Lobby of the National Works Agency, 140 Maxfield Avenue, Kingston 10, no later than 12:00 p.m. on Tuesday, March 13 2018.

Opening of Tenders: Tenders will thereafter be publicly opened at **12:15** p.m. on **Tuesday, March 13, 2018** in the Main Conference Room at the offices of the National Works Agency, 140 Maxfield Avenue, Kingston 10.
