### Invitation To Tender

#### **TENDER FOR MASONRY RETAINING WALL CONSTRUCTION: CHAPELTON BREAKAWAY, CLARENDON.**

The National Works Agency invites eligible contractors to submit **TENDERS FOR CHAPELTON BREAKAWAY LOCATED IN THE PARISH OF CLARENDON**. The works comprise of but is not limited to demolition and site clearance, earthworks such as rock excavation and boulder packing. Installation of 900mm diameter HDPE pipe culvert and rip-rap. Pavement works including preparation of formation, sub and base course and asphaltic concrete overlay (38 mm thick). Construction of rubble masonry retaining wall and parapet wall.

**Eligibility:** It is mandatory that contractors be on the Public Procurement Commission (PPC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grade 1 -2 in the Civil Engineering Works or General Road Works Categories. Tenderers must have a valid Tax Compliance Certificate (TCC).

**Availability:** Tender Documents will be made available as of **Friday, May 15, 2020**, at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

**Fee:** A non-refundable payment of J\$5,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

**Return of Tenders:** A Bid Security from a Registered Commercial Bank, Manager's Cheque or Insurance Company in the amount of \$500,000.00; PPC Certificate of Registration and a valid Tax Compliance Certificate (TCC), are to be placed in an envelope labelled "**MASONRY RETAINING WALL CONSTRUCTION: CHAPELTON BREAKAWAY LOCATED IN THE PARISH OF CLARENDON**". The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **10:00 a.m. on Monday, June 15, 2020**.

**Tender Opening:** The Tenders will be opened at **10:15 a.m. on Monday, June 15, 2020**, in the Conference area of the Regional and Special Projects Department, National Works Agency, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.
