Invitation To Tender

TENDER FOR RETAINING WALL CONSTRUCTION: RIVERSDALE, ST. CATHERINE.

The National Works Agency invites eligible contractors to submit **TENDERS FOR RETAINING WALL CONSTRUCTION: RIVERSDALE LOCATED IN THE PARISH OF ST. CATHERINE**. The works comprise of but is not limited to demolition & site clearance, earthworks, installation of HPDE Pipe 600 mm and splash pad; construction of Rubble Masonry Retaining wall, parapet wall & capping. Pavement works such as scarifying, sub base course, base course and asphaltic concrete overlay (38 mm thick).

Eligibility: It is mandatory that contractors be on the Public Procurement Commission (PPC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grade 1 -2 in the Civil Engineering Works or General Road Works Categories. Tenderers must have a valid Tax Compliance Certificate (TCC).

Availability: Tender Documents will be made available as of **Friday, June 5, 2020**, at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

Fee: A non-refundable payment of J\$5,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Return of Tenders: A Bid Security from a Registered Commercial Bank, Manager's Cheque or Insurance Company in the amount of \$400,000.00; PPC Certificate of Registration and a valid Tax Compliance Certificate (TCC) are to be placed in an envelope labelled **"RETAINING WALL CONSTRUCTION: RIVERSDALE LOCATED IN THE PARISH OF ST. CATHERINE"**. The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **10:00 a.m. on Friday, July 3, 2020**.

Tender Opening: The Tenders will be opened at **10:15 a.m. on Friday, July 3, 2020**, in the Conference area of the Regional and Special Projects Department, National Works Agency, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and NCC / PPC Certificate of Registration will be rejected.
