TENDER FOR ROAD REHABILITATION AND DRAINAGE IMPROVEMENT WORKS: MAY PEN TO SEVENS ROAD, CLARENDON

The National Works Agency invites eligible contractors to submit tenders for Rehabilitation Works: May Pen to Sevens Road, Clarendon. The works include but is not limited to site clearance, drain cleaning, formation preparation, base course application and double surface dressing along the road sections as specified.

Eligibility: It is mandatory that contractors be on the National Contracts Commission (NCC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grades 1 or 2 in the Asphaltic Concrete Works, or General Road Works categories

Availability: Tender Documents will be made available from **Wednesday, August 12, 2015**, until **Friday, August 21, 2015** from the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10, in the Directorate of Regional Implementation & Special Projects.

Fee: A non-refundable payment of J\$5,000 in cash or Manager's Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Tender Security: A tender bond issued by a registered bank or insurance company in the amount of \$800,000 or a Manager's Cheque in the sum of \$400,000 made payable to the "Chief Executive Officer - National Works Agency".

Return of Tenders: Completed tenders along with the required documents: National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), etc. are to be placed in an envelope labelled "**MAY PEN TO SEVENS ROAD, CLARENDON**". The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **10:00 a.m. on Wednesday, August 26, 2015**.

Tender Opening: The Tenders will be opened at **10:15 a.m., August 26, 2015** in the Main Conference Room, National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.
