## **Invitation To Tender**

## TENDER FOR ROAD REHABILITATION: BURNT GROUND, WILLIAMS TOWN NEW HOPE AND HOLT, ST. ELIZABETH

The National Works Agency invites eligible contractors to submit tenders for **ROAD REHABILITATION: BURNT GROUND, WILLIAMS TOWN, NEW HOPE AND HOLT LOCATED IN THE PARISH OF ST. ELIZABETH.** The works consist of demolition & site clearance, earthworks – engineered fill, drain cleaning & construction, pavement works such as preparation of formation, base course, pot hole repair, and application of asphaltic concrete overlay.

**Eligibility:** It is mandatory that contractors be on the National Contracts Commission (NCC)/Public Procurement Commission (PPC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grade 1 or 2 in the Civil Engineering Works or General Road Works Categories. Tenderers must have a valid Tax Compliance Certificate (TCC).

**Availability:** Tender Documents will be made available as of **Monday, November 18, 2019**, at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

**Fee:** A non-refundable payment of J\$5,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Return of Tenders: Completed tenders along with a Public Procurement Commission (PPC) /National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), are to be placed in an envelope labelled "ROAD REHABILITATION WORKS: BURNT GROUND, WILLIAMS TOWN, NEW HOPE AND HOLT LOCATED IN THE PARISH OF ST. ELIZABETH". The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than 10:00 a.m. on Wednesday, December 4, 2019.

**Tender Opening:** The Tenders will be opened at **10:15 a.m. on Wednesday December 4, 2019**, in the Regional and Special Projects Conference table, National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and NCC Certificate of Registration will be rejected.
