## **Invitation to Tender**

## TENDER FOR INFRASTUCTURE, ROAD REHABILITATION AND DRAINAGE IMPROVEMENT WORKS: DUMP TO MORAVIA (SILENT HILL), MANCHESTER

The National Works Agency invites eligible contractors to submit tenders for **Rehabilitation Works: Dump to Moravia (Silent Hill), Manchester.** The works include but is not limited to earth works, site clearance, rubble masonry retaining wall, formation preparation, base course application and Asphaltic Concrete 38mm application as specified.

**Eligibility:** It is mandatory that contractors be on the National Contracts Commission (NCC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grade 2 or 3 in the General Road Works and / or Civil Engineering categories.

**Availability:** Tender Documents will be made available from **Thursday, November 19, 2015, to Thursday December 03, 2015** from the National Works Agency's Corporate Office, 140 Maxfield Avenue, Kingston 10, in the Directorate of Regional Implementation & Special Projects.

**Fee:** A non-refundable payment of J\$3,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

**Tender Security:** A Tender Bond issued by a registered bank or insurance company in the amount of \$250,000 or a Manager's Cheque in the sum of \$160,000 made payable to the "Chief Executive Officer - National Works Agency."

Return of Tenders: Completed Tenders along with the required documents: National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), etc. are to be placed in an envelope labelled "DUMP TO MORAVIA (SILENT HILL), MANCHESTER." The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency's Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than 10:00 a.m. on Tuesday, December 08, 2015.

**Tender Opening:** The Tenders will be opened at 10:15am, December 08, 2015 in the Main Conference Room, at the National Works Agency's Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and National Contracts Commission (NCC) Certificate of Registration will be rejected.
