## **Invitation for Tender**

## CONSTRUCTION OF SEAWALL AND REVETMENT WORKS - FALMOUTH, TRELAWNY

The National Works Agency invites eligible contractors to submit tenders for the construction of a Seawall and Revetment works in Falmouth, Trelawny. The works include but is not limited to construction random rubble wall, parapet wall & coping, scarifying and application of Asphaltic Concrete to the affected road section, as specified.

**Eligibility:** It is mandatory that contractors be on the National Contracts Commission (NCC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grades 1 or 2 in the Civil Engineering or Marine Engineering categories.

**Availability:** Tender Documents will be made available from **Wednesday, March 18, 2015, until Wednesday, April 1, 2015** from the National Works Agency's, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

**Fee:** A non-refundable payment of J\$5,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

**Tender Security:** A tender bond issued by a registered bank or insurance company in the amount of \$950,000 or a Manager's Cheque in the sum of \$475,000 made payable to the "Chief Executive Officer - National Works Agency."

Return of Tenders: Completed Tenders along with the required documents National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), etc. are to be placed in an envelope labelled "Construction of a Seawall and Revetment works in Falmouth, Trelawny." The envelope should then be placed in the Tender Box similarly labelled and located in the Lobby of the National Works Agency's, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than 10:00 a.m. on Wednesday, April 8, 2015.

**Tender Opening:** The Tenders will be opened at **10:15 a.m., April 8, 2015** in the CEO's Conference Room, at the National Works Agency, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

All queries concerning the Tender Document shall be made in writing and addressed to: Marcia Dawes, Regional Coordinator, National Works Agency, 140 Maxfield Avenue, Kingston 10, by **Wednesday**, **April 1, 2015.** 

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and NCC Certificate of Registration will be rejected.
