### Invitation for Tender

#### TENDER FOR ROAD REHABILITATION WORKS: LAKES PEN ROAD, ST. CATHERINE

The National Works Agency invites eligible contractors to submit tenders for Road Rehabilitation Works: Lakes Pen Road, St. Catherine. The works include but is not limited to bushing & trimming of road banks, milling, the application of Asphaltic Concrete regulation and 38mm thick Asphaltic Concrete overlay along the road sections as specified.

**Eligibility:** It is mandatory that contractors be on the National Contracts Commission (NCC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grades 1 or 2 in the General Road Works or Asphaltic Concrete Works categories

**Availability:** Tender Documents will be made available as of **Wednesday February 4, 2015**, at the National Works Agency's, Corporate Office, 140 Maxfield Avenue, Kingston 10, in the Directorate of Regional Implementation & Special Projects.

**Fee:** A non-refundable payment of J\$5,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

**Tender Security:** A Tender Bond issued by a registered bank or insurance company in the amount of \$700,000 or a Manager's Cheque in the sum of \$350,000 made payable to the "Chief Executive Officer - National Works Agency".

**Return of Tenders:** Completed tenders along with the required documents National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), etc. are to be placed in an envelope labelled "**ROAD REHABILITATION WORKS: LAKES PEN ROAD, ST. CATHERINE**". The envelope should then be placed in the Tender Box similarly labelled and located in the Lobby of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10 no later than **10:00 a.m. on Wednesday, February 25, 2015**.

**Tender Opening:** The Tenders will be opened at **10:15 a.m. on February 25, 2015** in the Main Conference Room, at the National Works Agency, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

All queries concerning the Tender Document shall be made in writing and addressed to The Regional Coordinator, National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10, by **Wednesday, February 18, 2015**.

***Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and NCC Certificate of Registration will be rejected***
