Invitation To Tender

TENDER FOR ROAD REHABILITATION: SPAULDING - FRANKFIELD, CLARENDON

The National Works Agency invites eligible contractors to submit tenders for Spaulding - Frankfield located in the parish of Clarendon. The works comprise of but is not limited to demolition, site clearance (bushing and trimming of banks) and earthworks. Pavement works include scarifying, preparation and formation of pavement surface with an asphaltic concrete overlay (38mm thick).

Eligibility: It is mandatory that contractors be on the National Contracts Commission (NCC)/Public Procurement Commission (PPC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grade 1 -2 in the Civil Engineering Works or General Road Works Categories. Tenderers must have a valid Tax Compliance Certificate (TCC).

Availability: Tender Documents will be made available as of **Monday, August 26, 2019**, at the National Works Agency's, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

Fee: A non-refundable payment of J\$5,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Return of Tenders: Completed tenders along with a Bid Security (\$300,000.00) in the form of a Manager's Cheque from a local bank or Tender Bond from an insurance company; National Contract Commission (NCC)/ Public Procurement Commission (PPC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), are to be placed in an envelope labelled "**ROAD REHABILITATION WORKS: SPAULDING - FRANKFIELD LOCATED IN THE PARISH OF CLARENDON**". The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency's, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **10:00 a.m. on Monday September 16, 2019**.

Tender Opening: The Tenders will be opened at **10:15 a.m. on Monday, September 16, 2019**, in the Conference area of the Regional and Special Projects Department, National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and NCC/PPC Certificate of Registration will be rejected.
