Return of Tenders: Completed tenders along with Bid Security (300,000.00) in the form of a manager's Cheque from a local bank or tender bond from an insurance company, Public Procurement Commission (PCC)/ National Contracts Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), are to be placed in an envelope labelled **"ROAD REHABILITATION WORKS: DUNBAR'S RIVER - TORRINGTON, LOCATED IN THE PARISH OF WESTMORELAND"**. The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10.
