Invitation To Tender

TENDER FOR ROAD REHABILITATION WORKS: DUNBAR'S RIVER – TORRINGTON, WESTMORELAND.

The National Works Agency invites eligible contractors to submit tenders for **ROAD REHABILITATION WORKS: DUNBAR'S RIVER - TORRINGTON, LOCATED IN THE PARISH OF WESTMORELAND**. The works consist of but not limited to demolition and site clearance, earthworks- excavate soft spots, drain cleaning and construction, pavement works such as base course, prime coat and asphaltic overlay (38mm thick) and ancillary road works such as kerb and channel.

Eligibility: It is mandatory that contractors be on the National Contracts Commission (NCC)/ Public Procurement Commission (PPC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grade 1 or 2 in the Civil Engineering Works or General Road Works Categories. Tenders must have a valid Tax Compliance Certificate (TCC).

Availability: Tender Documents will be made available as of **Monday, November 25, 2019** at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10, in the Directorate of Regional Implementation & Special Projects.

Fee: A non-refundable payment of \$5,000.00 in cash or Manager's Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Return of Tenders: Completed tenders along with Bid Security (300,000.00) in the form of a manager's Cheque from a local bank or tender bond from an insurance company, Public Procurement Commission (PCC)/ National Contracts Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), are to be placed in an envelope labelled **"ROAD REHABILITATION WORKS: DUNBAR'S RIVER - TORRINGTON, LOCATED IN THE PARISH OF WESTMORELAND"**. The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **10:00 a.m. on Monday, December 9, 2019**.

Tender Opening: The Tenders will be opened at **10:15 a.m. Monday, December 9, 2019**, on the Regional and Special Projects Conference table, National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representative are invited to the opening.

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and NCC Certificate of Registration will be rejected.
