Invitation for Tender

ROAD REHABILITATION: MOCHO – ARCADIA, ST JAMES

The National Works Agency invites eligible contractors to submit tenders for Road Rehabilitation Works: Mocho – Arcadia, St. James. The works include but is not limited to the construction of random rubble wall, parapet wall & gabion wall; drainage improvement works inclusive of a U drain, V drain and French drain; as well as construction and application of Double Surface Dressing along the affected road section as specified.

Eligibility: It is mandatory that contractors be on the National Contracts Commission (NCC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grade 1 in the General Road Works, Asphaltic Concrete Works or Civil Engineering categories.

Availability: Tender Documents will be made available from **Wednesday, April 15, 2015, until Wednesday, April 29, 2015** from the National Works Agency's, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

Fee: A non-refundable payment of J\$5,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Tender Security: A Tender Bond issued by a registered bank or insurance company in the amount of \$900,000 or a Manager's Cheque in the sum of \$450,000 made payable to the "Chief Executive Officer - National Works Agency".

Return of Tenders: Completed tenders along with the required documents [National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), etc.] are to be placed in an envelope labelled **"ROAD REHABILITATION: MOCHO – ARCADIA, ST JAMES"** The envelope should then be placed in the Tender Box similarly labelled and located in the Reception Area of the National Works Agency's, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **10:00 a.m. on Wednesday May 6, 2015.**

Tender Opening: The Tenders will be opened at **10:15 a.m., Wednesday, May 6, 2015** in the Main Conference Room, at the National Works Agency, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

All queries concerning the Tender Document shall be made in writing and addressed to: Marcia Dawes, Regional Coordinator, National Works Agency, 140 Maxfield Avenue, Kingston 10, by **Wednesday April 29, 2015.**

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and NCC Certificate of Registration will be rejected.

THE NATIONAL WORKS AGENCY reserves the right not to accept the lowest, or any other tender, or to annul the tender process and reject all tenders at any time prior to the award without incurring any liability.
