TENDER FOR ROAD REHABILITATIVE WORKS: CHRISTIANA TO BROCKLEY, MANCHESTER

The National Works Agency invites eligible contractors to submit tenders for Road Rehabilitative Works on the road from Christiana to Brockley located in the parish of Manchester. The works consist of site clearance, drainage and pavement works.

Eligibility: It is mandatory that contractors be on the National Contracts Commission (NCC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grades 1 or 2 in the Civil Engineering Works or General Road Works Categories.

Availability: Tender Documents will be made available as of Wednesday, September 12, 2018, at the National Works Agency's, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

Fee: A non-refundable payment of J\$3,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Return of Tenders: Completed tenders along with the Bid Security (\$300,000.00) in the form of a Manager's Cheque from a local bank or insurance company, National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), are to be placed in an envelope labelled "**Road Rehabilitative Works for Christiana to Brockley, Manchester**". The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency's, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **11:00 a.m. on Wednesday, October 3, 2018.**

Tender Opening: The Tenders will be opened at **11:15 a.m., Wednesday, October 3, 2018**, in the Regional Implementation & Special Projects Conference Area, National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

All queries concerning the Tender Document shall be made in writing and addressed to: **Maira Williamson, Major Projects Manager (Acting)**, National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10; by **October 2, 2018.**

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and NCC Certificate of Registration will be rejected.
