TENDER FOR ROAD REHABILITATION WORKS:

IRIE LANE, NORWOOD, ST. JAMES

The National Works Agency invites eligible contractors to submit tenders for **Road Rehabilitation Works: Irie Lane, Norwood** located in the parish of St. James. The works consist of bushing & trimming of banks, drain cleaning, drainage improvement and road rehabilitation works.

Eligibility: It is mandatory that contractors be on the National Contracts Commission (NCC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grades 1 or 2 or 3 in the Civil Engineering Works or General Road Works Categories.

Availability: Tender Documents will be made available as of **Tuesday October 30, 2018**, at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

Fee: A non-refundable payment of J\$3,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Return of Tenders: Completed tenders along with the Bid Security (\$250,000.00) in the form of a manager's cheque from a local bank or tender bond from an insurance company, National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), are to be placed in an envelope labelled "**Road Rehabilitation Works: Irie Lane, Norwood St. James.**" The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **11:00 a.m. on Tuesday, November 13, 2018.**

Tender Opening: The Tenders will be opened at **11:15 a.m, Tuesday, November 13, 2018**, in the Main Conference Room, National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and NCC Certificate of Registration will be rejected.
