## Invitation to Tender

### TENDER FOR ROCK REVETMENT WORKS: REGGAE TRAIL, ST. ANN

The National Works Agency invites eligible contractors to submit tenders for Rock Revetment Works: Reggae Trail, St. Ann. The works include but are not limited to site clearance, earthworks and protective works along the road sections as specified.

**Eligibility:** It is mandatory that contractors be on the National Contracts Commission (NCC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Civil Engineering Works Category (GRADE 4) and or Marine Engineering Category (GRADE 3)

**Availability:** Tender Documents will be made available from **Thursday, December 10, 2015, until Thursday December 24, 2015** at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

**Fee:** A non-refundable payment of J\$3,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each tender document.

**Return of Tenders:** Completed tenders along with the required documents: National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), etc. are to be placed in an envelope labelled "**ROCK REVETMENT WORKS, ST. ANN.**" The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **10:00 a.m. on Monday, December 28, 2015.**

**Tender Opening:** The Tenders will be opened at **10:15 a.m. on December 28, 2015** in the Main Conference Room, at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.
