### Invitation To Tender

#### TENDER FOR ROAD REHABILITATION: ROSEWELL ROAD, CLARENDON

The National Works Agency invites eligible contractors to submit tenders for **ROAD REHABILITATION: ROSEWELL ROAD, LOCATED IN THE PARISH OF CLARENDON**. The works consist of demolition and site clearance, drain cleaning and construction pavement works such as base course, prime coat and asphaltic concrete overlay 38mm thick.

**Eligibility:** It is mandatory that contractors be on the National Contracts Commission (NCC)/ Public Procurement Commission (PPC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grade 1 or 2 in the Civil Engineering Works or General Road Works Categories. Tenders must have a valid Tax Compliance Certificate (TCC).

**Availability:** Tender Documents will be made available as of **Monday, December 16, 2019** at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10, in the Directorate of Regional Implementation & Special Projects.

**Fee:** A non-refundable payment of \$5,000.00 in cash or Manager's Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

**Return of Tenders:** Completed tenders along with Bid Security (300,000.00) in the form of a manager's Cheque from a local bank or tender bond from an insurance company, Public Procurement Commission (PCC)/ National Contracts Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), are to be placed in an envelope labelled "**ROAD REHABILITATION WORKS ROSEWELL ROAD, LOCATED IN THE PARISH OF CLARENDON**". The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **10:00 a.m. on Monday, January 13, 2020**.

**Tender Opening:** The Tenders will be opened at **10:15 a.m. on Monday January 13, 2019** in the Conference area of the Regional and Special Projects Department, National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

**Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and PPC Certificate of Registration will be rejected.**
