## **Invitation To Tender**

## TENDER FOR RUBBLE RETAINING WALL CONSTRUCTION: CHELSEA BREAKAWAY, PORTLAND.

The National Works Agency invites eligible contractors to submit tenders for **RUBBLE RETAINING WALL OF CHELSEA, LOCATED IN THE PARISH OF PORTLAND.** The works consist of but not limited to site clearance, earthworks, and rubble masonry retaining wall, pavement works such as base course, prime coat, and asphaltic concrete overlay (38 mm thick).

**Eligibility:** It is mandatory that contractors be on the National Contracts Commission (NCC)/ Public Procurement Commission (PPC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grade 1 or 2 in the Civil Engineering Works Category. Tenders must have a valid Tax Compliance Certificate (TCC).

**Availability:** Tender Documents will be made available as of **Friday, February 7, 2020**, at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10, in the Directorate of Regional Implementation & Special Projects.

**Fee:** A non-refundable payment of \$5,000.00 in cash or Manager's Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Return of Tenders: Completed tenders along with Bid Security (\$ 400,000.00) in the form of a manager's Cheque, bank guarantee from a local bank or tender bond from an insurance company, Public Procurement Commission (PCC)/ National Contracts Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), are to be placed in an envelope labelled "RUBBLE RETAINING WALL CONSTRUCTION: CHELSEA BREAKAWAY, LOCATED IN THE PARISH OF PORTLAND". The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than 10:00a.m. on Friday, February 28, 2020.

**Tender Opening:** The Tenders will be opened at **10:15 a.m. Friday, February 28th, 2020**, on the Regional and Special Projects Conference table, National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representative are invited to the opening.

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and NCC Certificate of Registration will be rejected.
