Invitation To Tender

TIBER RIVER BRIDGE JACKING PROJECT ST. MARY

The Government of Jamaica, through the Ministry of Economic Growth and Job Creation/ National Works Agency invites eligible contractors to submit tenders for the captioned works.

Scope of Works: Repairs to one of the existing Tiber River Bridge Abutments, which includes cutting holes in bridge deck, the driving of King and Bracing Piles, the supplying and installation of 4 no. Jacks and Tension Rods and jacking up of one end of the bridge and driving of permanent piles before lowering the bridge onto the new abutment and removal of jacks. Dismantle and cut down all temporary shoring and shoring frames and clear river bed of parts. Repair holes cut in concrete deck for piles and rods to pass through and leave the bridge in a condition suitable for full use by all vehicular traffic.

Eligibility: Tenderers must be registered with the Public Procurement Commission (PPC) in the Civil Engineering Works Category, Grade 1 and shall be in possession of valid Tax Compliance Certificates (TCC) in order to have their tenders considered.

Availability: Tender documents will be available as of **Monday, September 2, 2019** from the Directorate of Technical Services, National Works Agency, 140 Maxfield Avenue, Kingston 10.

Fee: A non-refundable payment of Three Thousand Dollars (\$3,000.00) in cash or manager's cheque, payable to the Chief Executive Officer, National Works Agency is required for each set of tender documents.

Return of Tenders: Completed Tender Documents together with all required enclosures (PPC registration and TCC) shall be placed in an envelope labelled "**TIBER RIVER BRIDGE JACKING PROJECT.**" The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, 140 Maxfield Avenue, Kingston 10, no later than **1:00 p.m. on Friday September 13, 2019.**

Opening of Tenders: Tenders will thereafter be publicly opened at **1:15 p.m. on Friday, September 13, 2019** in the Main Conference Room at the offices of the National Works Agency, 140 Maxfield Avenue, Kingston 10.

All enquiries concerning the Tender shall be made in writing and addressed to: Roger Smith, Director Technical Services, National Works Agency, 140 Maxfield Avenue, Kingston 10, by Monday September 9, 2019.

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and Public Procurement Commission (PPC) Certificate of Registration will be rejected.
