TENDER FOR ROAD & DRAINAGE REHABILITATION: CORNER GATE – WOOD HALL, ST. CATHERINE

The National Works Agency invites eligible contractors to submit **TENDERS FOR ROAD & DRAINAGE REHABILITATION CORNER GATE – WOOD HALL LOCATED IN THE PARISH OF ST. CATHERINE**. The works comprise of but is not limited to demolition and site clearance (bushing and trimming of banks), rock excavation, cleaning of side drains, earth drains, outlets and culverts. Construction of catch basins, concrete U & V drains and HDPE pipe installation. Pavement works include asphaltic concrete overlay (38mm thick), asphaltic concrete regulation, and pothole patch and repair. Road Markings, kerbs and pedestrian crossings.

Eligibility: It is mandatory that contractors be on the Public Procurement Commission (PPC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grade 1 in the Civil Engineering Works or General Road Works Categories. Tenderers must have a valid Tax Compliance Certificate (TCC).

Availability: Tender Documents will be made available as of **Monday, April 27, 2020**, at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

Fee: A non-refundable payment of J\$5,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Return of Tenders: Completed tenders along with a Bid Security (\$500,000.00) in the form of a Manager's Cheque from a local bank or Tender Bond from an insurance company, PPC Certificate of Registration and a valid Tax Compliance Certificate (TCC), are to be placed in an envelope labelled **"ROAD & DRAINAGE REHABILITATION WORKS: CORNER GATE – WOOD HALL LOCATED IN THE PARISH OF ST. CATHERINE"**. The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **10:00 a.m. on Monday, June 15, 2020**.

Tender Opening: The Tenders will be opened at **10:15 a.m. on Monday, June 15, 2020**, in the Conference area of the Regional and Special Projects Department, National Works Agency, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and NCC / PPC Certificate of Registration will be rejected.
