### Invitation To Tender

#### ROAD REHABILITATION WORKS: JACKSON TOWN TO STEWART TOWN, TRELAWNY

The National Works Agency invites eligible contractors to submit tenders for **ROAD REHABILITATION WORKS: JACKSON TOWN TO STEWART TOWN, TRELAWNY**. The works consists of but is not limited to demolition and site clearance, earth works, construction of concrete "v" drain, asphalt concrete regulation application of 38mm thick asphaltic concrete overlay and along the road section as specified.

**Eligibility:** It is mandatory that contractors be on the National Contracts Commission (NCC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grades 1 or 2 in the Civil Engineering or General Road works category.

**Availability:** Tender Documents will be made available from **Tuesday, February 12, 2019, until Tuesday, February 26, 2019** from the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

**Fee:** A non-refundable payment of J\$3,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each tender document.

**Tender Security:** A tender bond issued by a registered bank or insurance company in the amount of \$300,000.00 or a manager's cheque in the sum of \$300,000.00 made payable to the "Chief Executive Officer - National Works Agency".

**Return of Tenders:** Completed tenders along with the required documents: National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC) are to be placed in an envelope labelled "**JACKSON TOWN TO STEWART TOWN, TRELAWNY**". The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **10:00 a.m. on Tuesday, February 26, 2019**.

**Tender Opening:** The Tenders will be opened at **10:15 a.m., Tuesday, February 26, 2019** in the Main Conference Room, at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.
