ROAD REHABILITATION AND DRAINAGE IMPROVEMENT WORKS: MAJESTIC GARDENS (SPANISH TOWN ROAD to MARCUS GARVEY DRIVE) ST. ANDREW

The National Works Agency invites eligible contractors to submit tenders for Rehabilitation Works: Majestic Gardens (Spanish Town Road to Marcus Garvey Drive), St. Andrew. The works include but is not limited to site clearance, drainage construction, formation preparation, base course application and Double Surface Dressing along the road sections as specified.

Eligibility: It is mandatory that contractors be on the National Contracts Commission (NCC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grades 1 or 2 in the Asphaltic Concrete Works, or General Road Works categories.

Availability: Tender Documents will be made available from **Tuesday October 20, 2015, until Monday November 2, 2015** from the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

Fee: A non-refundable payment of J\$5,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each Tender Document.

Tender Security: A Tender Bond issued by a registered bank or insurance company in the amount of \$560,000 or a Manager's Cheque in the sum of \$280,000 made payable to the "Chief Executive Officer - National Works Agency".

Return of Tenders: Completed tenders along with the required documents: National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), etc. are to be placed in an envelope labelled "**MAJESTIC GARDENS (SPANISH TOWN ROAD to MARCUS GARVEY DRIVE), ST. ANDREW**". The envelope should then be placed in the Tender Box similarly labelled and located in the Lobby of the National Works Agency's, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **10:00 a.m. on Tuesday, November 03, 2015**.

Tender Opening: The Tenders will be opened at **10:15 a.m., Tuesday, November 3, 2015** in the Main Conference Room, at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.
