## **Invitation for Tender**

## ROAD REHABILITATIVE WORKS: TREDEGAR PARK - JACKSON VIA CROSS PEN KENSINGTON, ST. CATHERINE

The National Works Agency invites eligible contractors to submit tenders for Road Rehabilitative Works and Drainage Improvement for Tredegar Park - Jackson via Cross Pen Kensington located in the parish of St. Catherine. The works consist of demolition and site clearance, earth works, drainage and pavement works.

**Eligibility:** It is mandatory that contractors be on the National Contracts Commissions (NCC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grades 1 or 2 in the Civil Engineering Works or General Road Works Categories. Tenderers must have a valid Tax Compliance Certificate (TCC).

**Availability:** Tender Documents will be made available as of **Friday August 24, 2018**, at the National Works Agency's, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

**Fee:** A non-refundable payment of J\$3,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Return of Tenders: Completed tenders along with a Bid Security (\$150,000.00) in the form of a Manager's Cheque from a local bank or Tender Bond from an insurance company, National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), are to be placed in an envelope labelled "Road Rehabilitative Works for Tredegar Park - Jackson via Cross Pen Kensington located in the parish of St. Catherine". The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than 11:00 a.m. on Friday, September 7, 2018.

**Tender Opening:** The Tenders will be opened at **11:15 a.m. on Friday September 7, 2018,** in the Main Conference Room, National Works Agency's, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

All queries concerning the Tender Documents shall be made in writing and addressed to: Moira Williamson, Major Projects Manager (Acting), National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10; by Friday August 24th, 2018.

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and NCC Certificate of Registration will be rejected.
